Sub: Recognition certificate for the school under sub-rule (4) of Rule-11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Sir/Madam,

With ref. to your application dated 09/02/2024 and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to the Dhansiri Valley Public School, Numaligarh for class I to VIII for a period of three years w.e.f. 03/05/2024 to 03/04/2027.

The above sanctioned is subject to fulfillment of following conditions-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The school shall abide by the provision of Right of Children to Free and Compulsory Education Act, 2009 and Right of Children to Free and Compulsory Rule, 2011.
3. The school shall admit in class I to the extent of 25% of the strength of class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre-primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the school shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursement school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them. 21.
7. The School shall ensure:
 - (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - (b) No child shall be subjected to physical punishment or mental harassment.
 - (c) No child is required to pass any board examination till the completion of elementary education.
 - (d) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
 - (e) Inclusion of Students with disabilities/special needs as per provision of the Act.
 - (f) The teachers are recruited with minimum qualification as laid under section 23 (1) of the Act.
 - (g) The teachers performs its duties specified under section 24 (1) of the Act and
 - (h) The teachers shall not engage himself for private teaching activities.
8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

9. The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
10. The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

11. No unrecognized classes shall run within the premise of the school or outside in the same name of school.
12. The school building or other structures or the grounds are used only for the purposes education and skill development.
13. The school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
14. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the statements of Accounts should be sent to the DEEO every year.
15. The recognition Code No. allotted to your school is **GT/R/001/2024** this may please be noted and quoted for any correspondence with this office.
16. The school furnishes such reports and information as may be required by the Director of Education/District Education Officer from time to time and complies with such instruction of the State Govt./Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school .
17. Renewal of registration of Society if any be ensured.
18. Other Conditions as per Annexure III enclosed.
